Stability: The lyophilized material is stable for several years when stored frozen. After

reconstitution the material is stable for at least 1 year when stored frozen in

aliquots with 0.05% sodium azide added as a preservative.

Caution: Refer to the enclosed MSDS for information regarding lectins. The aluminum

seals have sharp edges and the vial itself may have cracks which can cause

lacerations. Use caution when opening the vial.

Remarks: Jacalin has been used to purify human serum IgA. Different preparations of the

> lectin have been shown to bind several other immunoglobulins as well. Although the lectin has a primary affinity for terminal α-Galactose residues it does recognize the T-antigen which has a terminal β-Galactose. It does not bind to

other β-Galactose structures as found in lactose.
